# 11. New Business

# 11.1. Education Service Report

The report is included in the agenda package as part of the Assistant Superintendent, Curriculum & Learning report. Administration reviewed the contents of the report.

Trustees support the proposed plan and asked what the Board can do to support this initiative. Administration to provide Trustees with key speaking points for discussions with stakeholders and partners.

The associated professional development plan will be shared with the Board in the fall of 2025.

#### 11.2. Jordan's Principle Update

Administration is currently attending meetings that are being held every 2 weeks. The changes put limitations on the NWT, which are of significant concern. The lack of support for families in need is also a concern.

Trustees recommend the Board Chairperson and Superintendent send a letter to both Indigenous Services Canada and Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC) with YK1 concerns, before the election, to ensure this becomes a highlighted issue early on for the new federal government.

#### Motion #: 10/04-08/24-25

BE IT FURTHER RESOLVED THAT the Board directs the Policy Committee and staff to amend the Board's Bylaws to reflect this restriction, and to clearly outline appropriate channels for Trustee engagement with school communities that uphold governance best practices and ethical standards.

Trustees noted that PACs are advisory in nature and Trustees are governance in nature and trustee attendance at PAC meetings blurs the lines between those two groups' mandate.
