The meeting was called to order at 6:31 PM. Seven (7) Trustees were present. Quorum was met.

Chairperson Wasylciw welcomed everyone to the meeting and thanked everyone for their contributions to another successful YK1 presence at the Chamber of Commerce Trade Show. Of note, Trustee Brookes' balloons were a hit again this year.

10. Unfinished Business

10.1. Update on École William McDonald Middle School (WMS)/École Allain St.Cyr (EASC) Schools' Parking

Administration met with CFSTNO and YCS superintendents to observe the current flow of traffic. This resulted in the following:

- YK1 and CFSTNO to track down a traffic study done for WMS/EASC parking in the past, and
- Research what City criteria for parking is

Administration noted that the city wants the new exit blocked off because only the original entrance and exit must remain.

Trustees suggest asking the Department of Education, Culture and Employment (ECE) to do traffic studies for both WMS/EASC and, if required, at It'ò.

Trustees think more parents are dropping their children off now than was the case in the past.

Trustees requested ongoing updates as this item progresses.

11. New Business

11.1. Property Tax Requisition

Motion #: 08/05-13/24-25

I move that the Yellowknife Education District No. 1 Board of Trustees rescind the previously passed motion 02/04-28/24-25 and amend the previously requisitioned education property tax amount from \$8,803,221 to \$8,038,923 as part of ensuring that there is a consistent education property tax rate for all residents.

Moved by: Trustee Snaggs Seconded by: Trustee Shortt Carried

Further discussions with YCS resulted in a recommendation to request a reduced increase to the education property tax, and that spreading the funds required to fully fund the program over future years in an effort to reduce the socio-economic impacts on Yellowknife residents.

Trustees noted the need for the YK1 Board of Trustees to work to ensure YK1 is funded to 100% for the students and their success. YK1 has not requested

an increase in the education property tax for many years, increased costs are making the request necessary. There were concerns that this smaller increase would leave programs underfunded for the next school year and draw down from accumulated surplus at a rapid pace.

Chairperson Wasylciw thanked the City for accommodating the change in our request.

11.2. YK1 School Reviews

Abbreviated reports for each school are in the package. The process was reviewed. Based on the full reports, schools have developed their school improvement plans. Trustees asked to have School Improvement Plans (SIPs) shared at a future Board meeting and would like schools to provide suggestions of how the Board can support the SIPs. Trustees feel the reports will give school administrators and staff valuable information to work with.

The YK1 Board wants to ensure staff and students are supported in their goals and looks forward to a check-in in the fall as SIPs are implemented.

11.3. International PD Requests

11.3.1. US travel in July

Motion #: 09/05-13/24-25

I move that the Yellowknife Education District No. 1 Board of Trustees approve the international travel to the United States for professional development.

Administration noted that there is no cost to the District. The staff member is using their own professional Development (PD) funds.

Trustees congratulated Principal McInnis for being selected to attend.

Trustees requested that in the future the title for this item be changed to *International Travel Requests* for clarity.

11.4. Draft 2025-2026 Operational Plan

The Draft 2025-2026 Operating Plan is included in the package. It will be submitted to ECE for feedback. Any changes requested, if necessary will be made, and then it will be resubmitted with the budget approved by the Board.

Administration expects a few changes concerning the mental health and wellness program, and the use of the Federal food funding. Administration also expects that next year, questions specific to the JK to Grade 3 curriculum renewal will be included as part of the Operating Plan template provided by ECE.

Motion #: 11/05-13/24-25

I move that the Yellowknife Education District No. 1 Board of Trustees adopt the draft 2025-2026 Operational Plan as presented for discussion, with the Department of Education, Culture and Employment and further review.

Trustees agreed that the criteria for the award should be reviewed regularly and noted that the recognition is intended to ensure more Indigenous students feel comfortable with embracing their culture. It was also noted that the recognition needs to be viewed through the lens of reconciliation. Trustees would encourage more Elders and Knowledge keepers be involved in

the selection process. Each student can only be recognized once per grade category.

Trustees applaud all the students recognized.

Administration talked about how creative ways are being found to provide PD to staff across the district. Trustees applaud the creation of the Professional Development (PD) committee.

In a response to a question about wellness it was indicated that on average we have a 4% staff absentee rate due to medical, across the district.
