10. Unfinished Business

10.1. Draft 2024-2025 Operating Budget

10.3. National Food Funding Follow-up

Administration responded to a trustee's request to determine what an ideal food program would look like. Trustees inquired if having one person in the district responsible for a district-wide food program would be helpful. Administration indicated that one school with a high need does have a dedicated person. Other schools are being creative to deliver a food program. More discussions are needed to determine the full extent of needs before the district makes a funding request. Trustees noted the need to include what will be needed (training, supplies, etc) to ensure sanitization and food safety requirements are met in the funding request.

10.4. YK1 Montessori Program

Administration clarified that this program started in 2005. Numerous discussions with stakeholders resulted in the following motion.

11.1. Appointment of Superintendent/CEO

Administration was tasked with having further discussions with the Northern Mosaic Network to clarify the appropriate use of a Pride version of the YK1 logo and to develop guidelines for the creation and use of a Pride and possibly other special occasion versions of the YK1 logo for Board consideration.

11.4. Cell Phone Information

Trustee Brookes spoke about the reason he requested this item be added to the agenda. He would like to request a statement that trustees should use to answer questions members of the community might have about cell phone use in schools which resulted in the following motion.

Motion #: 10/06-27/23-24

I move that the Yellowknife Education District No. 1 Board of Trustees Direct Administration to prepare a briefing note that describes:

- a) The current classroom and school management of cellular/smartphone use by students;
- b) Any differences in management for different grade levels; and
- c) What is being done to monitor the effectiveness of this management?

The administration made trustees aware that there is an Administrative Procedure (AP) related to cell/smartphone use in schools. It was also noted that school policies align with the AP.

After the discussion, Trustee Brookes requested permission to withdraw Motion 10/06-27/23-24. The Chair called for and then announced the Board's

unanimous consent to withdraw the motion. Unanimous consent was given.

Administration responded to questions about fall attendance at the high school, and the mentoring program for staff.
