6. District Wide Communication

Trustee Drew indicated some parents have indicated that information (e.g. Bussing) distributed to schools from district office does not appear to be going out from every school. She suggested district wide information be sent from the district office directly to parents. Administration indicated this used to be possible via the previous website platform but the new platform does not have this functionality. Information Technology Services will be asked for input on a mechanism to allow the district office to send directly to families. Trustee Bell indicated the PR Committee will be doing a deep dive into district wide communication.

7. Facilities Committee

Facilities Committee Chair Drew informed the Board of Trustees that funding for emergency projects will be brought to the Board.

Administration indicated there are three emergent items (phone system at SJF, stage door at WMS, and fence at RLN). Proposed projects will be sent to the Facilities Committee for review. MLAs were made aware that YK1 would be seeking clarification of the SJF MOU.

Facilities Committee Chair Drew also indicated there are other projects that need attention (roof leak at NJM, generator at Ithò, and pellet boiler at SJF).

Administration indicated the leak at NJM is not emergent. It was determined Įtł'ò did not need a generator during the build but this may change over time. Operations to determine what a generator would be needed for. The pellet boiler at SJF has been repaired.

Trustee Snaggs suggested the creation of a detailed list to bring to the Facilities Committee and then the Finance Committee for consideration.

Administration indicated there are some positive variances (\$300K) which could be used to complete the emergent projects within the current budget.

Superintendent Aziz requested an in camera COW session before tonight's board meeting.

9. Negotiations Committee

The first Negotiations Committee meeting will be set for the week of March 6, 2023. Administration will reach out to David Johnson to provide some preliminary information for the meeting. Trustee Drew suggested the committee do their best not to request a change to the proposed dates as this could cause a considerable delay.
