Vice Chairperson Spence said YK1 is working with the other school boards in Yellowknife on the issue of JK bussing. At this time, the three boards have come to a joint decision that bussing for Junior Kindergarten students in 2017-2018 cannot be implemented in a way that fully addresses safety issues and bussing costs. While it is a priority to offer equitable access to Yellowknife schools, our boards' mandate to ensure student safety remains our highest priority.

# Moved – Vice Chairperson Spence; Seconded – Trustee Shortt

I move that a joint committee of trustee representatives from all three Yellowknife Boards be struck to further research bussing for JK students with the possibility of implementation in the 2018/2019 school year.

Vice Chairperson Spence said Admin and Chair has been working with the three Yellowknife boards to go over the JK bussing issue and identify costs and risks of bussing.

Chairperson Stephenson said this is an agreement by all three Boards and they will be passing a like motion. Further documents will be shared once all three Boards have passed the same motion.
