I move the Board of Trustees of Yellowknife Education District No. 1 accept the collective agreement which was negotiated with the NWTTA with details to be released later today.

- Trustee Brookes thanked the negotiating team for all of the work they put into the negotiations. He extended a thank you to Dave Johnson, our negotiator from Alberta. He said it was a fair and equitable settlement for all parties.
- Chairperson Stephenson said it is a four-year agreement. YK1 is following the GNWT as they just negotiated their agreement with the NWTTA. He noted a press release will be issued this afternoon. Union members voted 93.4% in favour of the new

contract and saw a 91.1% voter turnout. He noted November 9, 2016 was when the two parties reached an agreement in principle and it was ratified by NWTTA last night. Salary increases over the four years are 0%, 0%, 1%, 1%. The union was seeking and saw gains in improvements in working conditions. We explained YK1's fiscal responsibilities and explained our challenges of introducing JK and the funding impacts associated with that. Other items negotiated were discretionary leave provisions, sick leave credit increase, an increase to the principal's allowance and the housing allowance was added to salaries instead of a separate benefit.
